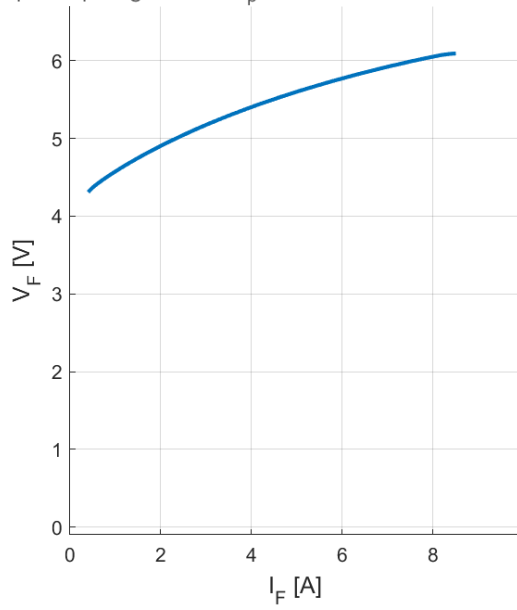

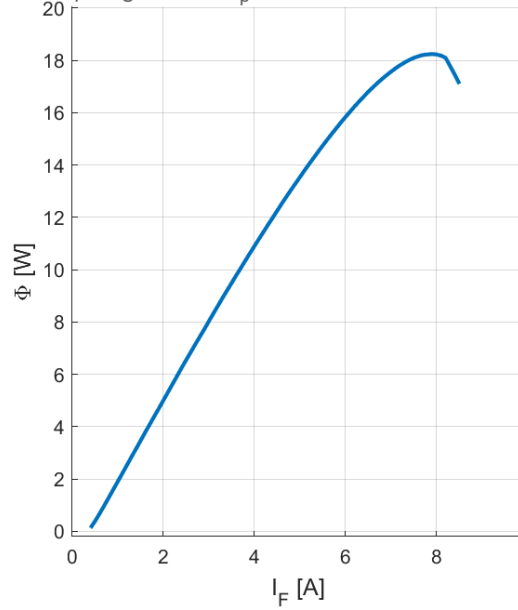

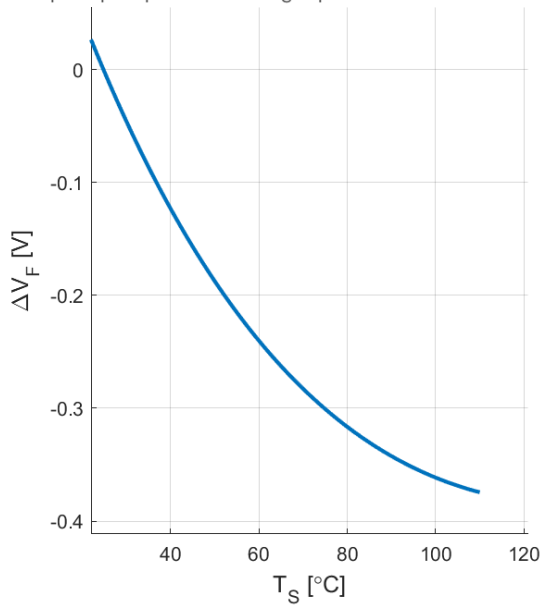

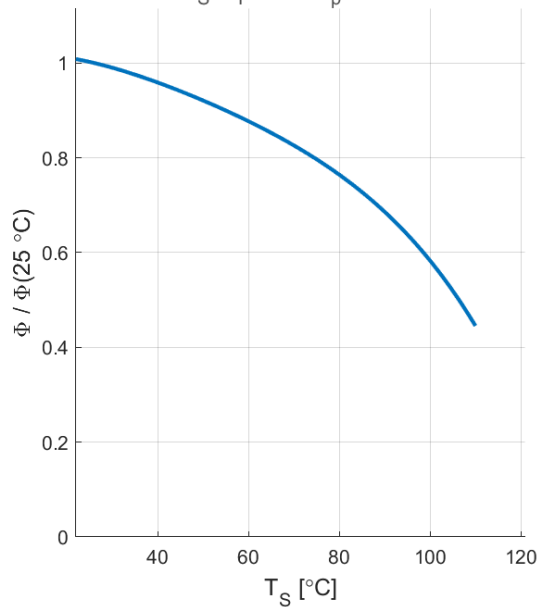
Relative Forward Voltage ¹⁾

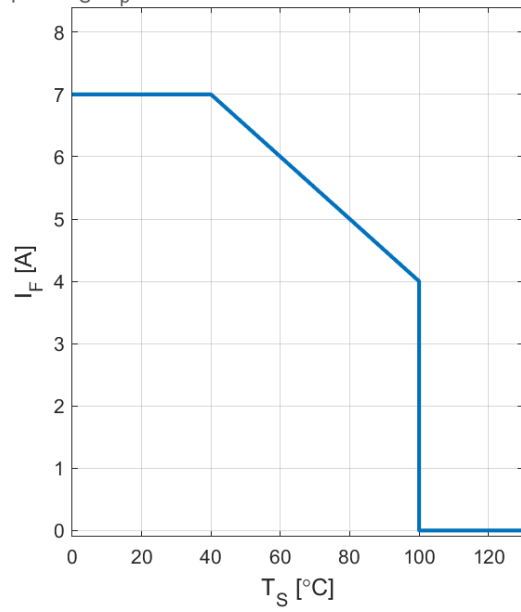
Relative Radiant Power ¹⁾

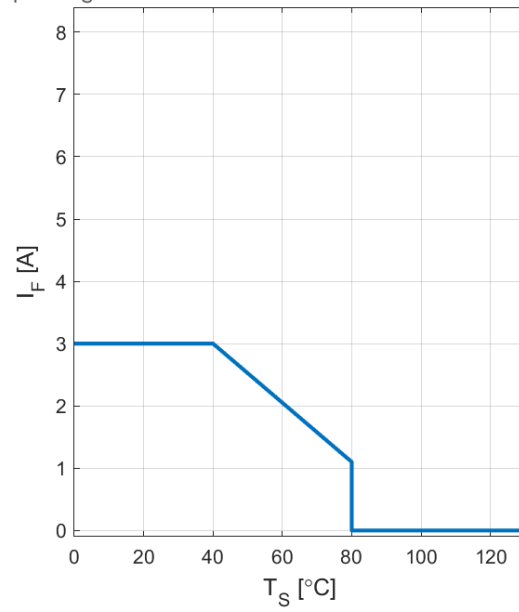
Max Permissible Pulse Current

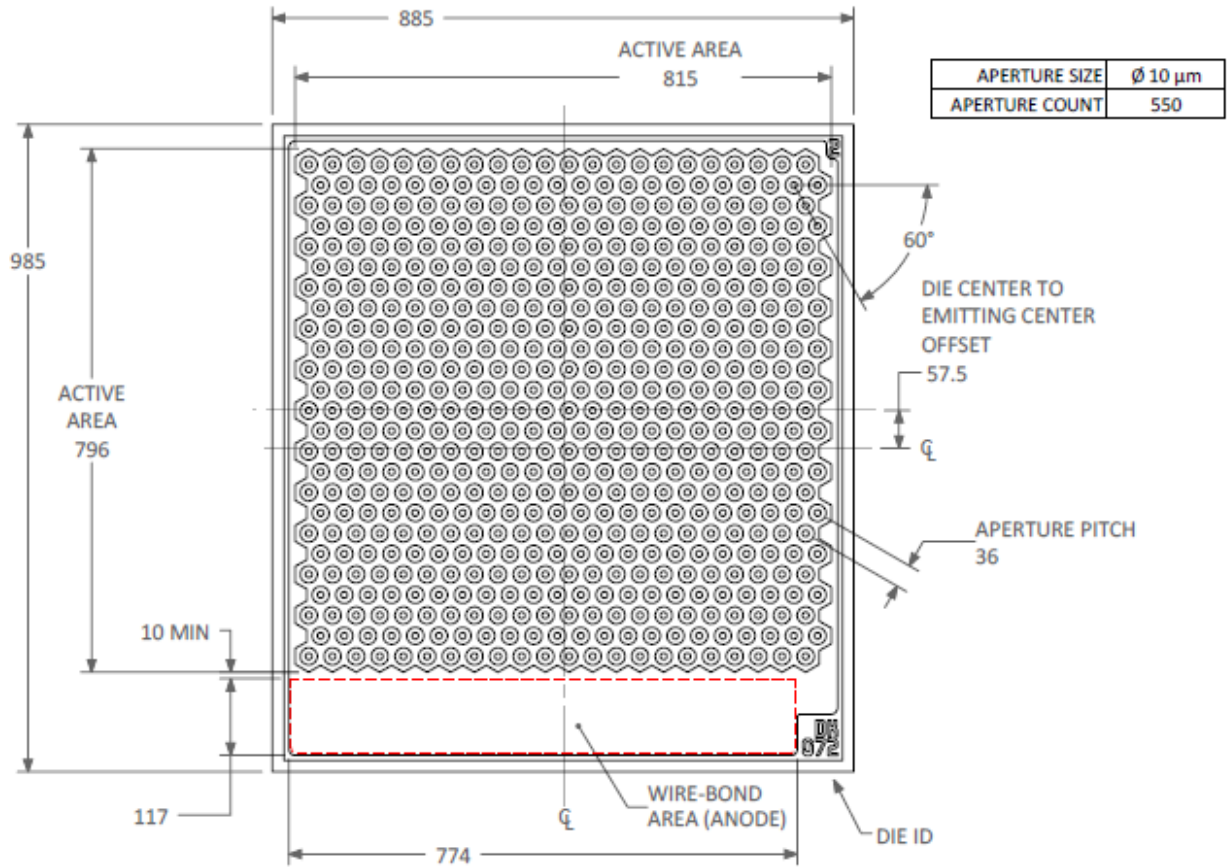


Max Permissible Current

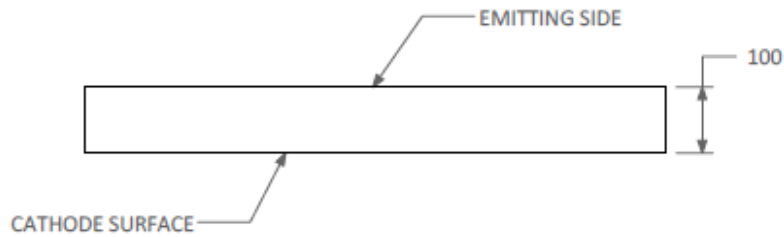
